The responses provided by the company and the client herein are true and accurate, and each party has the right to rely upon the information provided by the other as a basis for this agreement. Further, both parties acknowledge that the responses set forth herein shall constitute part and parcel of this agreement.

All 5 day hunts start on a Monday and conclude on Friday. All 3 day hunts start on Monday and conclude on Wednesday. All clients arrive in Saskatoon the Sunday before hunt, and depart the Thursday or Saturday after hunt.

- A. The Company represents and warrants to the Client that it is duly licensed by all applicable, provincial and local authorities to conduct the hunt(s) described herein and that the Company will conduct such hunt(s) in accordance with all national, state, provincial and local laws, rule and ordinances applicable to the hunt(s)
- B. It is understood that this contractual agreement does not constitute or imply any guarantees by the Company that any particular species of animal will be obtained by the Client. However, it is fully understood that the Company will make every reasonable effort to place the Client in an area and position where the animal sought could be taken.
- C. All payments to the Company must be made in cash, travelers checks, or certified checks. Final payment must be paid upon arrival, or by that date indicated above.
- D. The Company's fee does not include the cost of any commercial air transportation unless specified above. The Company may make arrangements for such transportation at the direction of the Client.
- E. If for any reason the Client fails to arrive in the Company's camp as scheduled, no adjustments or compensation will be made.
- F. If for any reason the Client chooses to depart at an earlier date than scheduled, such early departure shall be at the Clients own expense and there shall be no refund.
- G. Deposit is non-refundable for any reason on hunts cancelled by the Client or failure to arrive on scheduled date.
- H. The Company and their respective employees and agents shall take all reasonable care and precautions for the safety of the Client however, the Client acknowledges that he or she is taking part in an outdoor activity involving inherent risks and therefore the Client hereby releases and forever discharges the Company and its employees from any damages whether personal injury or financial which the Client may or any party claiming through the Client encounter as a result of partaking in the hunt."
- I. The Client hereby authorizes the Company to use any photographs of himself and/or the wildlife harvested by the hunter for the Company's use. The Company may use these photographs for any commercial use whatsoever.
- J. Jurisdiction: It is agreed by both parties that this contract shall be governed, interpreted, and enforced pursuant to the laws of the country, states, provinces, and locality in which the hunt(s) take place.
- K. Any changes or alterations to the agreement must be made in writing and signed by both parties.
- L. Outfitter will not be responsible for medical problems or limitations of the Client.
- M. The Client acknowledges that he is responsible for any and all costs or damages which Lucky Lake Hunting Adventures Inc. may be held responsible for by virtues of any damages suffered by any person, animal, and/or property as a result of any actions of the Client. Without limiting the generality of the foregoing this shall include any damages which may be incurred by Lucky Lake Hunting Adventures Inc. or any other third party including damages to persons, dogs, or other animals, and or any property. The Client agrees to indemnify and save harmless Lucky Lake Hunting Adventures Inc. from any and all claims, demands, damages and costs on a solicitor and Client basis concerning an such damages caused by the Client.
